## Amendments to

Local Policy 12-602 Deeming a Reporting Issuer in Certain Other Canadian Jurisdictions to Become a Reporting Issuer in New Brunswick

- 1. Local Policy 12-602 Deeming a Reporting Issuer in Certain Other Canadian Jurisdictions to Become a Reporting Issuer in New Brunswick is amended by this instrument.
- 2. The title is amended by striking out "Deeming a Reporting Issuer in Certain Other Canadian Jurisdictions to Become" and substituting "Designating a Reporting Issuer in Certain Other Canadian Jurisdictions to be".
- 3. The paragraph preceding section 1 is amended
  - (a) by striking out "Section 96(1)" wherever it appears and substituting "subsection 1.1(2)";
  - (b) by striking out "Act" and substituting "New Brunswick Securities Act (Act)".
- 4. Section 1 is amended
  - (a) in subsection 1.1
    - (i) by striking out "1.1" and substituting "1(1)";
    - (ii) by striking out "section 96(1)" and substituting "subsection 1.1(2)";
    - (iii) by striking out "New Brunswick Securities Act (the "Act") and substituting "Act";
    - (iv) by striking out "deeming" after "for an order" and substituting "designating";

- (v) by striking out "("a Deeming Order")" and substituting "(Designation Order)".
- (b) in subsection 1.2
  - (i) by striking out "1.2" and substituting "1(2)";
  - (ii) by striking out "section 1.1" and substituting "subsection 1(1)";
  - (iii) by striking out "sections 1.3 and 1.4 of Part 1 and Parts 3 and 4" and substituting with "subsections 1(3) and 1(4)";
  - (iv) by striking out "section 96(1)" and substituting with "subsection 1.1(2)".
- (c) in subsection 1.3
  - (i) by striking out "1.3" and substituting "1(3)";
  - (ii) by striking out "section 96(1)" and substituting "subsection 1.1(2)".
- (d) in subsection 1.4
  - (i) by striking out "1.4" and substituting "1(4)";
  - (ii) by striking out "section 96(1)" and substituting "subsection 1.1(2)".
- 5. Section 2 is amended
  - (a) in subsection 2.1
    - (i) by striking out "2.1" and substituting "2(1)";
    - (ii) by striking out "section 96(1)" and substituting "subsection 1.1(2)";
    - (iii) by striking out "Deeming Order" and substituting "Designation Order";
    - (iv) by striking out ":" after "on an exchange if";
    - (v) by striking out "2.1.1" and substituting "(a)";
    - (vi) by striking out "2.1.2" and substituting "(b)".
  - (b) in subsection 2.2
    - (i) by striking out "2.2" and substituting "2(2)";

- (ii) by striking out "subsection 2.1.2" and substituting "paragraph 2(1)(b)";
- (iii) by striking out "section 96(1)" and substituting "subsection 1.1(2)".
- 6. Section 3 is amended
  - (a) in subsection 3.1
    - (i) by striking out "3.1" and substituting "3(1)";
    - (ii) by striking out "section 96(1)" and substituting "subsection 1.1(2)";
    - (iii) by striking out ":" after should include".
  - (b) in paragraph 3.1.1 by striking out "3.1.1" and substituting "(a)".
  - (c) in paragraph 3.1.2 by striking out "3.1.2" and substituting "(b)".
  - (d) in paragraph 3.1.3 by striking out "3.1.3" and substituting "(c)".
  - (e) in paragraph 3.1.4 by striking out "3.1.4" and substituting "(d)".
  - (f) in paragraph 3.1.5
    - (i) by striking out "3.1.5" and substituting "(e)";
    - (ii) by striking out ":" after "particulars of" in this same paragraph;
    - (iii) by striking out "(a)" and substituting "(i)" before "any known ongoing";
    - (iv) by striking out "(i)" and substituting "(A)" before "a Canadian securities";
    - (v) by striking out "(ii)" and substituting "(B)";
    - (vi) by striking out "(b)" and substituting "(ii)".

(g) in paragraph 3.1.6

- (i) by striking out "3.1.6" and substituting "(f)";
- (ii) by striking out ":" after "particulars of" in this same paragraph
- (iii) by striking out "(a)" and substituting "(i)";
- (iv) by striking out "(b)" and substituting "(ii)".

- (h) in paragraph 3.1.7 by striking out "3.1.7" and substituting "(g)".
- (i) in paragraph 3.1.8 by striking out "3.1.8" and substituting "(h)".
- (j) in paragraph 3.1.9
  - (i) by striking out "3.1.9" and substituting "(i)";
  - (ii) by striking out "Section 22 a)" and substituting "paragraph 22 a)".
- 7. Section 4 is amended
  - (a) by striking out "4.1";
  - (b) striking out "Deeming Order" and substituting "Designation Order".
- 8. Section 5 is amended by striking out "5.1".
- 9. Schedule "A" to Local Policy 12-602 is amended
  - (a) in paragraph "1) c)" striking out "an order deeming an issuer" and substituting "an order designating an Issuer";
  - (b) in paragraph "1) d)", striking out "133 Prince William Street, Suite 606" and substituting "85 Charlotte Street, Suite 300" and, striking out "E2L 2B5" and substituting "E2L 2J2".
- 10. This instrument comes into force on 24 September 2007.
