**Amendments to
Local Policy 12-603**

Deeming a Reporting Issuer to Cease to be a Reporting Issuer in New Brunswick

1. **Local Policy 12-603 *Deeming a Reporting Issuer to Cease to be a Reporting Issuer in New Brunswick* is amended by this instrument.**
2. **The title is amended by striking out “Deeming” and substituting “Designating”.**
3. **Part 1 is amended**
 - (a) **in the paragraph preceding section 1) of Part 1**
 - (i) **by striking out “deeming” and substituting “designating”;**
 - (ii) **by striking out “Section 95” wherever it appears and substituting “subsection 1.1(1)”.**
 - (b) **in section 1)**
 - (i) **by striking out “1)” and substituting “1(1)”;**
 - (ii) **by striking out “Section 95” and substituting “subsection 1.1(1)”;**
 - (iii) **by striking out “a)” and substituting “(a)”;**
 - (iv) **by striking out “i)” and substituting “(i)”;**
 - (v) **by striking out “•” wherever it appears and substituting “(A)”, “(B)”, “(C)”, and “(D)” respectively;**
 - (vi) **by striking “b)” and substituting “(b)”.**
 - (c) **in section 2)**
 - (i) **by striking “2)” and substituting “1(2)”;**

(ii) **by striking out “section 95” and substituting** “subsection 1.1(1);

(iii) **by striking out “Securities Act” and substituting** “*New Brunswick Securities Act (Act)*”.

(d) **in section 3)**

(i) **by striking out “3)” and substituting** “1(3)”;

(ii) **by striking out “Section 22 a)” and substituting** “paragraph 22 a)”.

(e) **in section 4) by striking out “4)” and substituting** “1(4)”.

4. **Part 2 is amended**

(a) **by striking out “1)”**.

(b) **by striking out “effect” and substituting** “force”.

5. **Schedule A to Local Policy 12-603 is amended**

(a) **in the address section by striking out “133 Prince William Street, Suite 606 Saint John, New Brunswick E2L 2B5” and substituting** “85 Charlotte Street, Suite 300 Saint John, New Brunswick E2L 2J2”;

(b) **in the “RE:” line**

(i) **by striking out “Section 95” and substituting** “subsection 1.1(1)”;

(ii) **by striking out “Securities Act” and substituting** “*New Brunswick Securities Act*”.

(c) **in the first paragraph**

(i) **by striking out “section 95” and substituting** “subsection 1.1(1)”;

(ii) **by striking out “deemed” and substituting** “designated”.

6. **Schedule B to Local Policy 12-603 is amended**

(a) **in the “RE:” line**

(i) **by striking out “Section 95” and substituting** “subsection 1.1(1)”;

(ii) **by striking out “Securities Act” and substituting** “*New Brunswick Securities Act*”.

(b) in the first paragraph

(i) by striking out “section 95” and substituting “subsection 1.1(1)”;

(ii) by striking out “deemed” and substituting “designated”.

(c) in the last paragraph by striking out “deemed” and substituting “designated”.
