IMPLEMENTING INSTRUMENT 55-804

ADOPTING NATIONAL INSTRUMENT 55-102 *SYSTEM FOR ELECTRONIC DISCLOSURE BY INSIDERS (SEDI)*, FORMS 55-102F1, 55-102F2, 55-102F3, 55-102F4, 55-102F5, 55-102F6 AND IMPLEMENTING COMPANION POLICY 55-102CP

PART 1 – DEFINITIONS

- 1.1 “NI 55-102” means National Instrument 55-102 – *System for Electronic Disclosure by Insiders (SEDI)* of the Canadian Securities Administrators consolidated to 29 December 2006.
- 1.2 “55-102F1” means Form 55-102F1 *Insider Profile*.
- 1.3 “55-102F2” means Form 55-102F2 *Insider Report*
- 1.4 “55-102F3” means Form 55-102F3 *Issuer Profile Supplement*
- 1.5 “55-102F6” means Form 55-102F6 *Insider Report*

PART 2 – ADOPTION AS A RULE

- 2.1 “NI 55-102”, as amended by this instrument, is adopted as a Rule under the *Securities Act*.

PART 3 – AMENDMENTS TO NI 55-102

- 3.1 Section 1.1, the definition of “transfer report” is amended by adding “New Brunswick” after “Ontario”.
- 3.2 Subsection 3.2(1) is amended by adding “New Brunswick” after “Quebec”.
