Notice and Request for Comment

Publication of proposed Local Rule 25-501 *Designation as a Market Participant* (the "**Proposed Rule**") as set out in Schedule "A".

Substance and Purpose

The Proposed Rule designates "an issuer that is not a reporting issuer in New Brunswick that distributes securities in reliance on any of the exemptions in subsections 2.3(1), 2.5(1) or 2.10(1) of National Instrument 45-106 *Prospectus Exemptions* ("NI 45-106") as a "market participant" under the *Securities Act*, SNB 2004 c. S-5.5 (the "Act").

The purpose of the Proposed Rule is to authorize compliance officers to conduct compliance reviews of issuers who rely on certain exemptions in NI 45-106, namely:

- i) the accredited investor exemption;
- ii) the family, friends and business associates exemption; and
- iii) the minimum amount investment exemption.

As a result of being designated as a "market participant" under the *Act*, these issuers would also be subject to certain other provisions and requirements in the *Act*, as applicable, including: section 162: *Record-keeping*, section 167: *Fees and expenses for compliance reviews*, section 169: *Fees and expenses for disclosure reviews*, section 184: *Orders in the public interest*, section 187: *Applications to the Court of Queen's Bench* and section 200: *Regulations and Rules*.

Designation as a Market Participant

2. An issuer that is not a reporting issuer in New Brunswick that distributes securities in reliance on any of the exemptions in subsections 2.3(1), 2.5(1) or 2.10(1) of National Instrument 45-106

Prospectus Exemptions is designated a market participant under the Securities Act.
