ORDER

WHEREAS:

- On April 26, 2021, Edward Wagnies filed a Notice of Appeal seeking to appeal a decision of the Director
 of Consumer Affairs, which decision was issued on January 12, 2021. In the Notice of Appeal,
 Mr. Wagnies also requested an extension of the time to file the Notice of Appeal;
- 2. Subsection 21(1) of the *Direct Sellers Act* stipulates that a person who is directly affected by a decision of the Director of Consumer Affairs may appeal it to the Tribunal within 30 days after the date of the decision;
- 3. Subsection 21(1.1) of the *Direct Sellers Act* provides that the Tribunal may extend the time for appealing a decision, before or after the expiration of time, if it is satisfied that there are reasonable grounds for

an extension;

4. Edward Wagnies contacted the Registrar of the Tribunal by telephone on numerous occasions about appealing the Director of Consumer Affairs' decision. During these telephone conversations,

Mr. Wagnies indicated that he did not have a computer, nor access to the internet and that he had difficulty reading and writing. As a result, the Registrar provided Mr. Wagnies with the telephone

number for the Law Society to obtain assistance in preparing his *Notice of Appeal*;

5. During a subsequent telephone conversation with the Registrar, Mr. Wagnies indicated that the Law Society referred him to the John Howard Society for help in filling out the *Notice of Appeal*;

6. On April 26, 2021, the Registrar received a fax from the John Howard Society attaching Mr. Wagnies'

Notice of Appeal;

7. On April 28, 2021, the Registrar served the *Notice of Appeal* upon the Director of Consumer Affairs;

3. The Director of Consumer Affairs consents to an extension of the time to file the *Notice of Appeal* provided that this does not prejudice the timelines in terms of providing the *Record of the Decision*-

making Process;

9. Pursuant to rule 5.3(5) of the *Rules of Procedure*, the Director of Consumer Affairs would normally have

until May 13, 2021 to file her Record of the Decision-making Process; and

10. Rule 1.5(2) of the Rules of Procedure provides that the Tribunal may extend the time prescribed by the

Rules of Procedure.

THEREFORE, IT IS HEREBY ORDERED THAT:

1. Mr. Wagnies' lack of computer and internet access combined with his difficulty reading and writing

constitute reasonable grounds for an extension of the time to file the *Notice of Appeal*;

2. The time to file the Notice of Appeal is extended to April 26, 2021; and

3. The time for filing the *Record of the Decision-making Process* is extended to May 20, 2021.
