**An Order Deeming Certain Reporting Issuers to Cease to be Reporting Issuers in
New Brunswick**

Blanket Order 13-501

Section 208

Interpretation

Defined terms contained in National Instrument 14-101 *Definitions* have the same meaning in this order unless they are defined in this order.

Background

1. On August 30, 2004 the New Brunswick Securities Commission (the Commission) issued Order 11-901 *Recognition of Certain Exchanges and Jurisdictions* (Order 11-901/2004) which, in paragraph (a), recognized the TSX Venture Exchange (TSX-V) and the Toronto Exchange Inc. (TSX) as exchanges under subsection 35(1)(a) of the Act for the purpose of the definition of "reporting issuer" in subsection 1(1)(c) of the Act.
2. The effect of Order 11-901/2004 was that all issuers trading on the TSX-V or the TSX became reporting issuers in New Brunswick on that date or upon listing if at a later time.
3. Effective September 21, 2005 the Commission repealed paragraph (a) of Order 11-901/2004. Any issuer that became listed on the TSX-V or the TSX on or after that date did not become a reporting issuer in New Brunswick solely by reason of such listing.
4. Notice 51-701 announced the repeal of paragraph (a) of Order 11-901/2004 and provided a simplified procedure whereby issuers who became reporting issuers in New Brunswick solely by operation of paragraph (a) of Order 11-901/2004 (11-901 Issuers) could apply to cease to be a reporting issuer in New Brunswick.
5. 11-901 Issuers were informed of Notice 51-701 through
 - a. the TSX Bulletin,
 - b. the Commission website, and
 - c. two series of letters sent to the address indicated on that issuer's SEDAR profile.

6. 11-901 Issuers were initially given until December 19, 2005 to file an application to cease to be a reporting issuer in the simplified form. This deadline was extended to January 19, 2006.
7. Most 11-901 Issuers affected by paragraph (a) of Order 11-901/2004 used the simplified procedure to cease to be a reporting issuer. Some 11-901 Issuers (as listed in Appendix A)(the Residual 11-901 Issuers) have yet to indicate to the Commission whether or not they wish to remain reporting issuers in New Brunswick. Commission staff have made repeated attempts by mail and telephone to contact the Residual 11-901 Issuers, but have not received any indication from them that that they wish to remain reporting issuers in New Brunswick.
8. In addition, the Residual 11-901 issuers have not made any continuous disclosure filings that would indicate their intention to continue to be a reporting issuer in New Brunswick.
9. Commission staff have notified the Residual 11-901 Issuers, at their address indicated on their SEDAR profile, of the Commission's intention to make this blanket order.
10. There is no benefit to the public that the Residual 11-901 issuers remain reporting issuers in New Brunswick.

Order


The Commission is satisfied that it would not be prejudicial to the public interest to grant this order.
