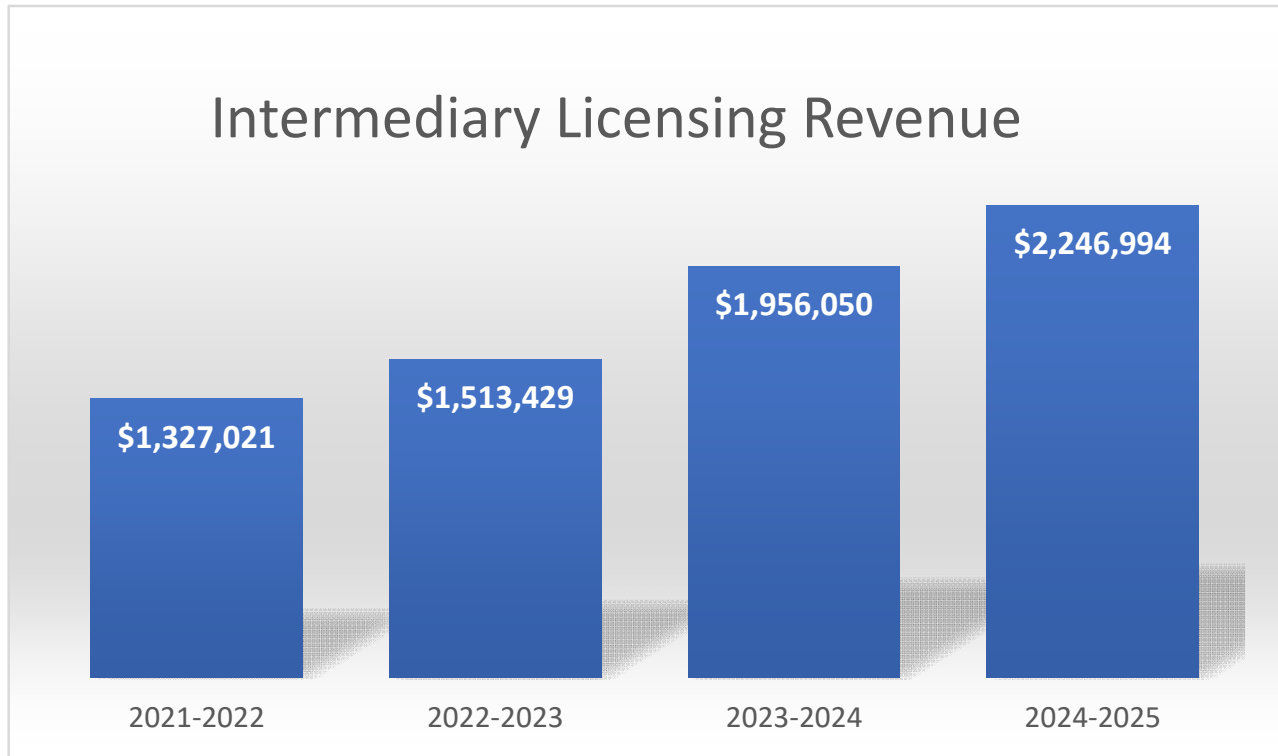


Table 1 - Revenue collected from Licensing Fees imposed as per Insurance Act.

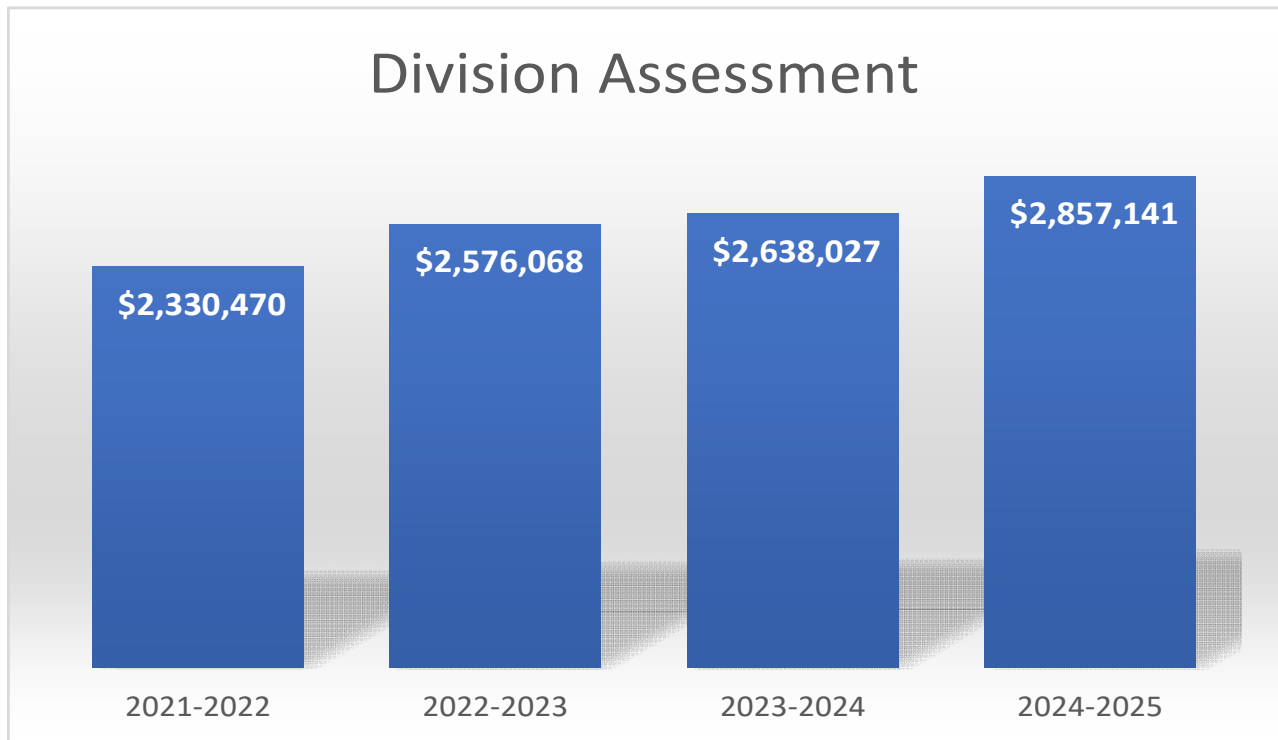


Table 2- Cost Recovery based on Insurance Act, S. 94.

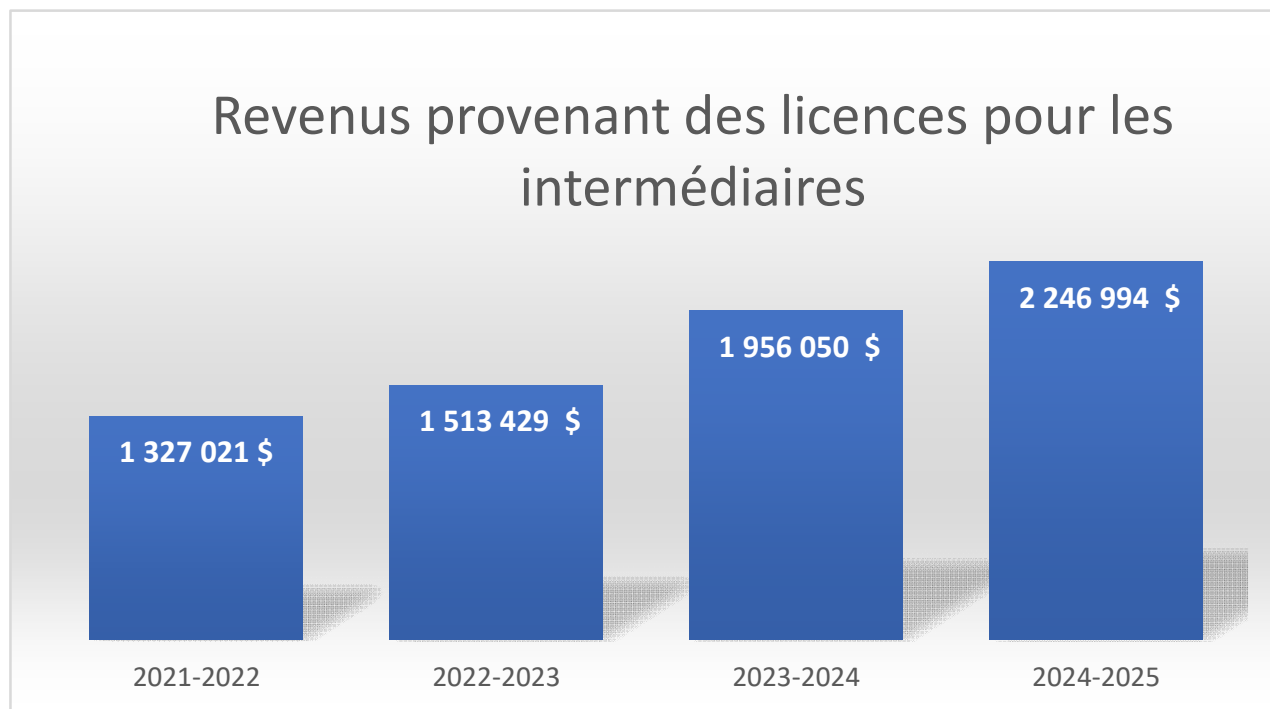


Tableau 3 – Revenus perçus provenant des droits de licence imposés par la Loi sur les assurances.

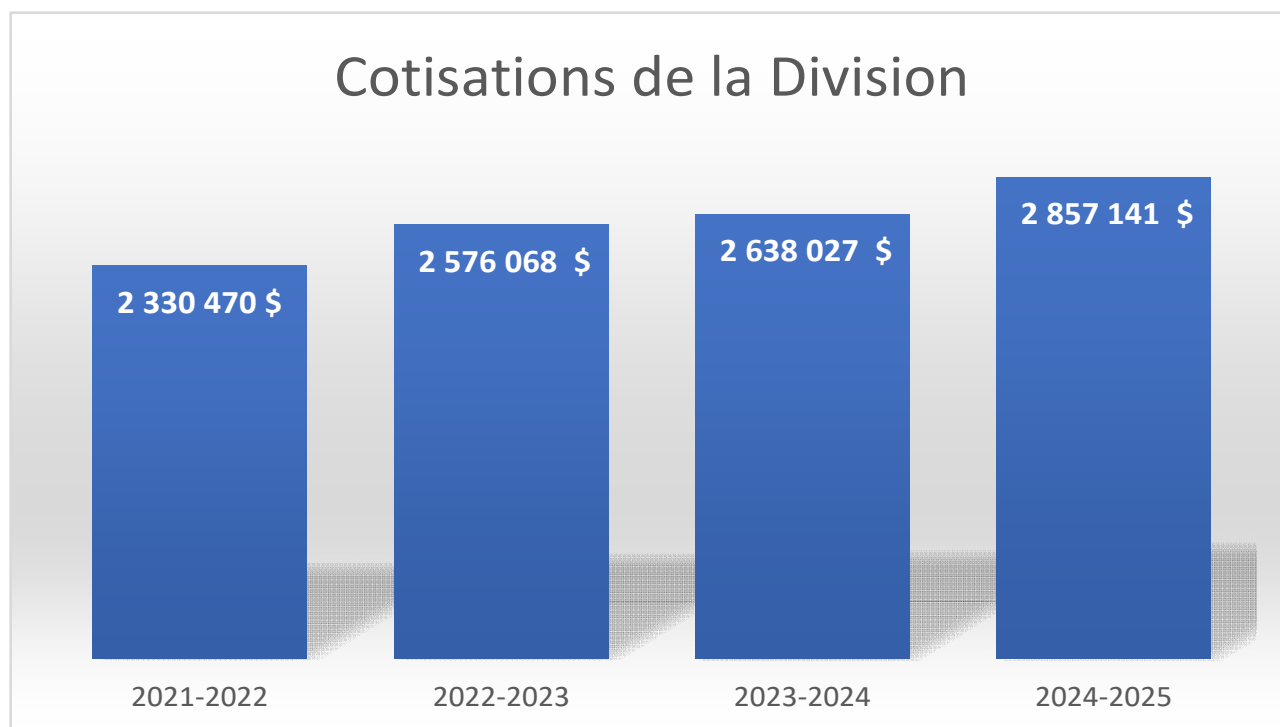


Tableau 4- Recouvrement des coûts conformément à l'article 94 de la Loi sur les assurances.

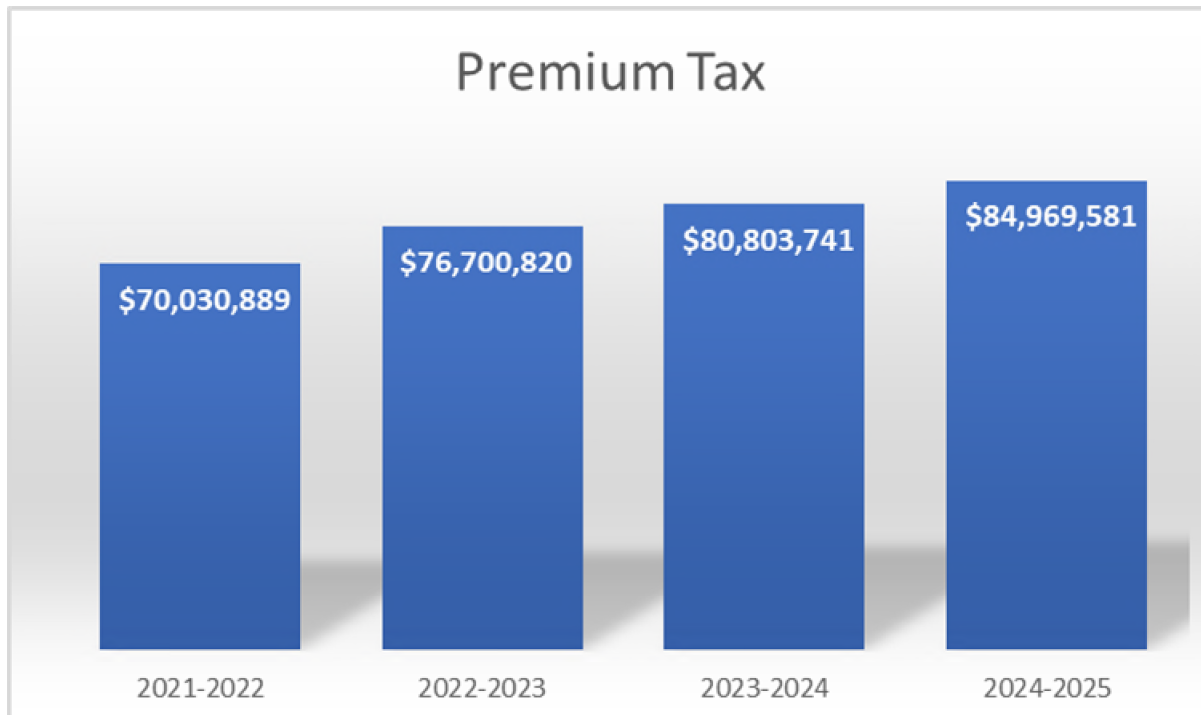

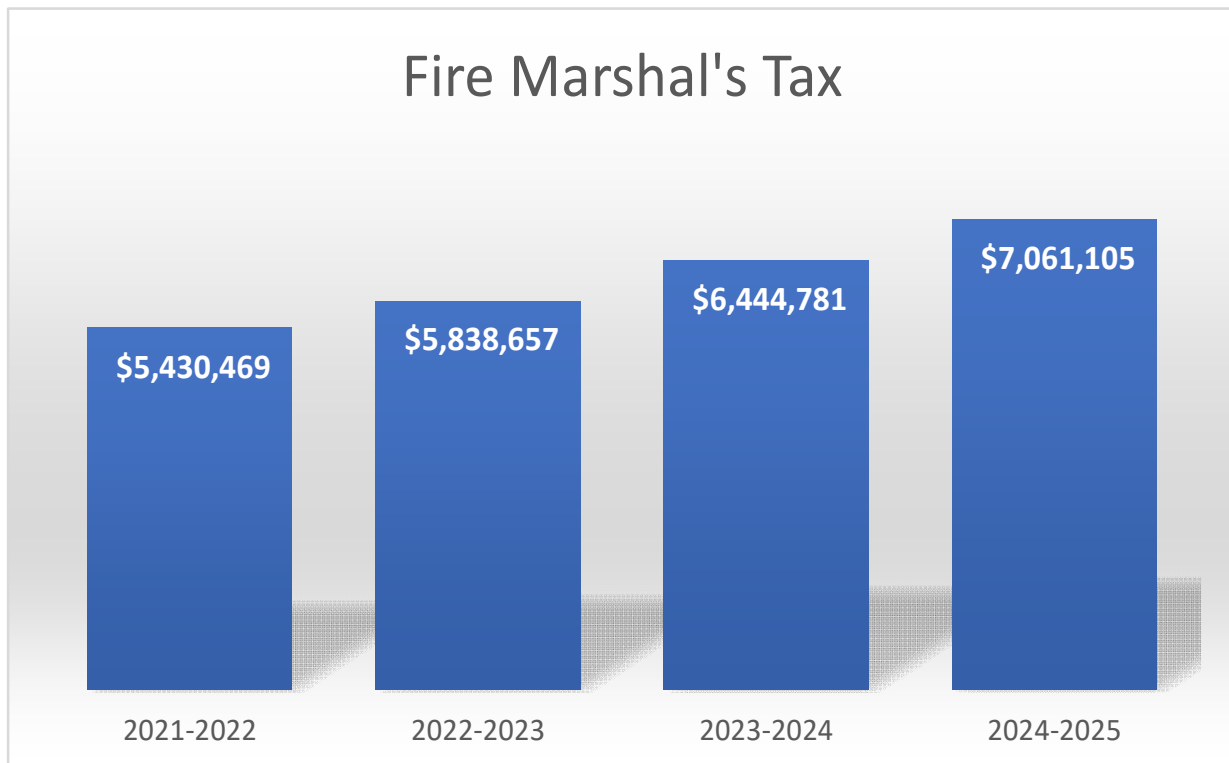
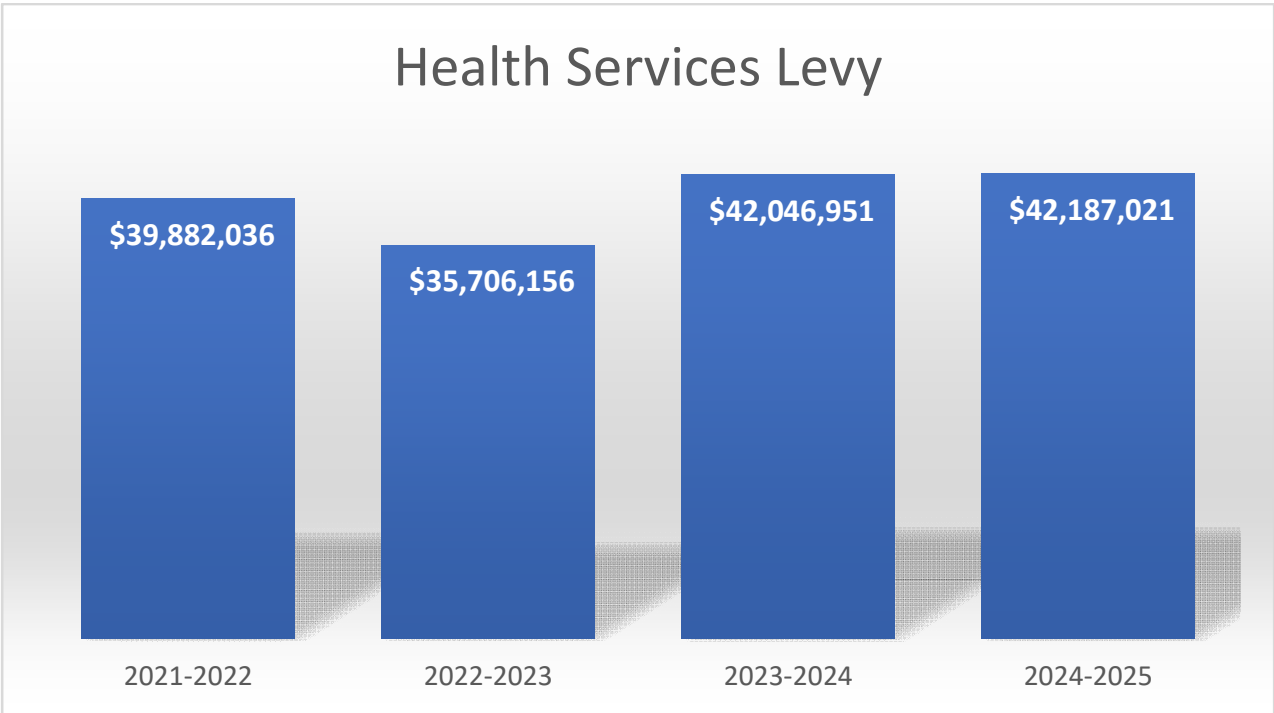
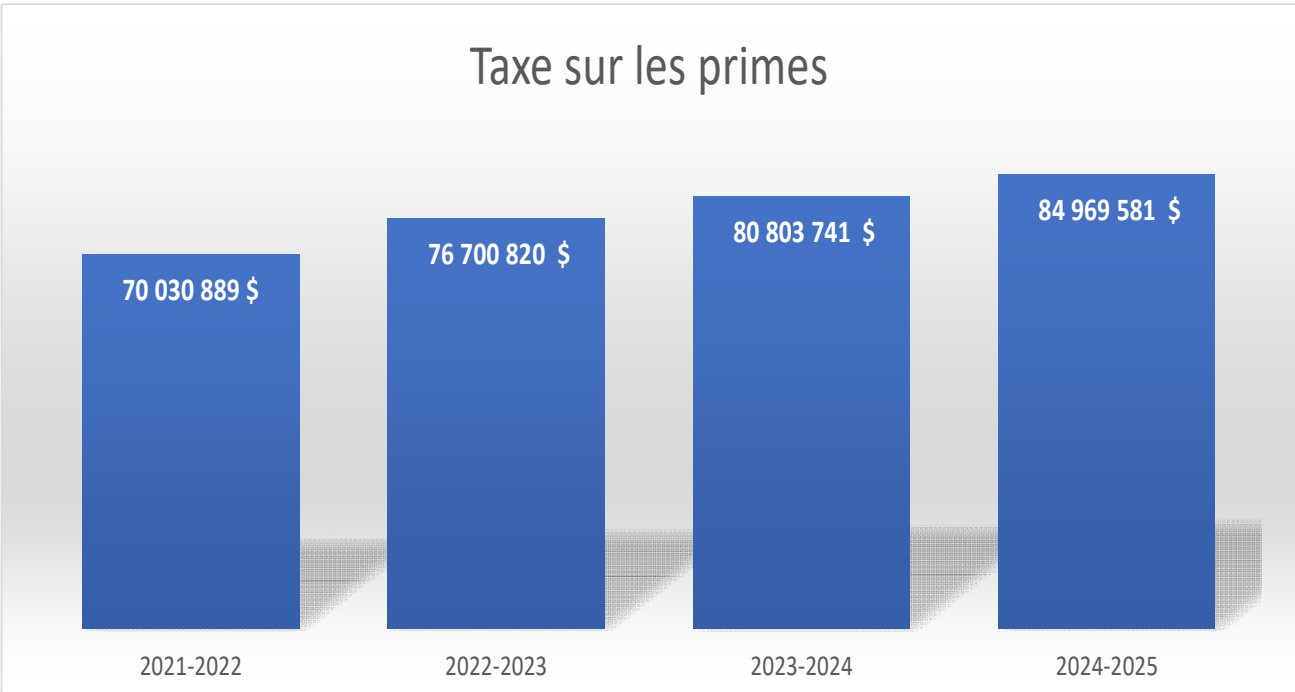


Table 6 - Collected as set out in the Fire Prevention Act S. 22 (1-4).

*Tableau 8 – Revenus perçus conformément à la Loi de la taxe sur les primes d’assurance.*

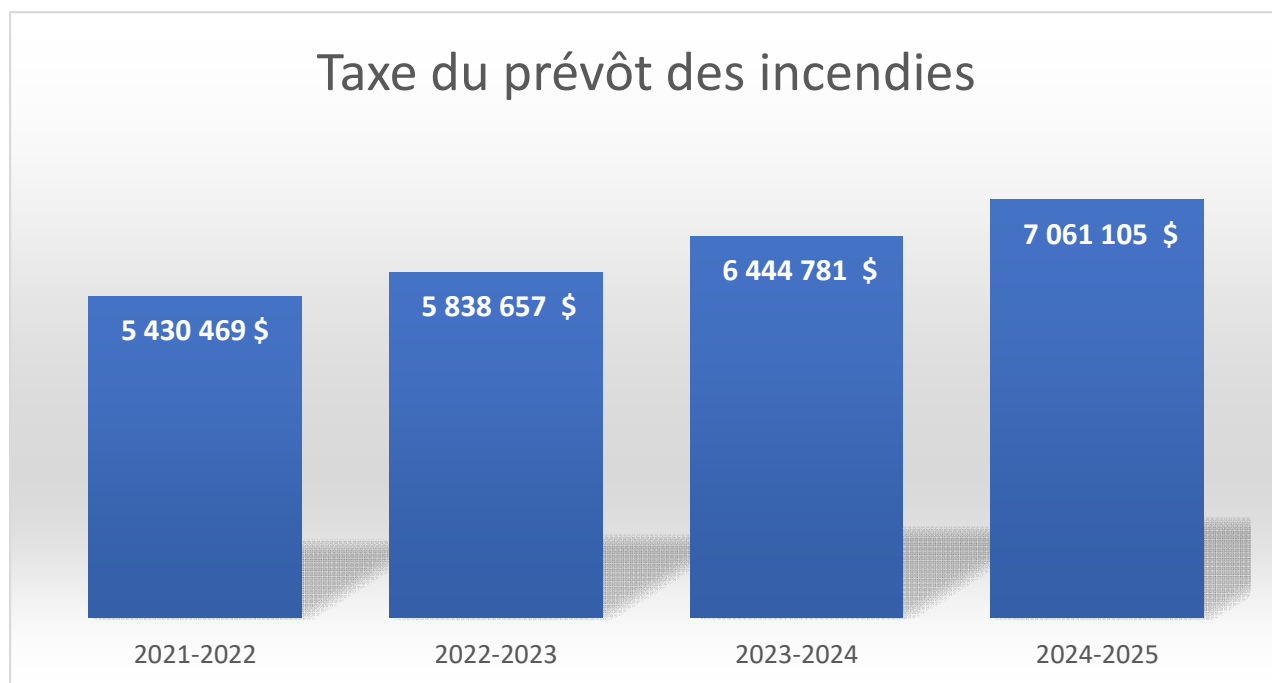


Tableau 9 – Revenus perçus conformément aux paragraphes 22(1) à 22(4) de la Loi sur la prévention des incendies.

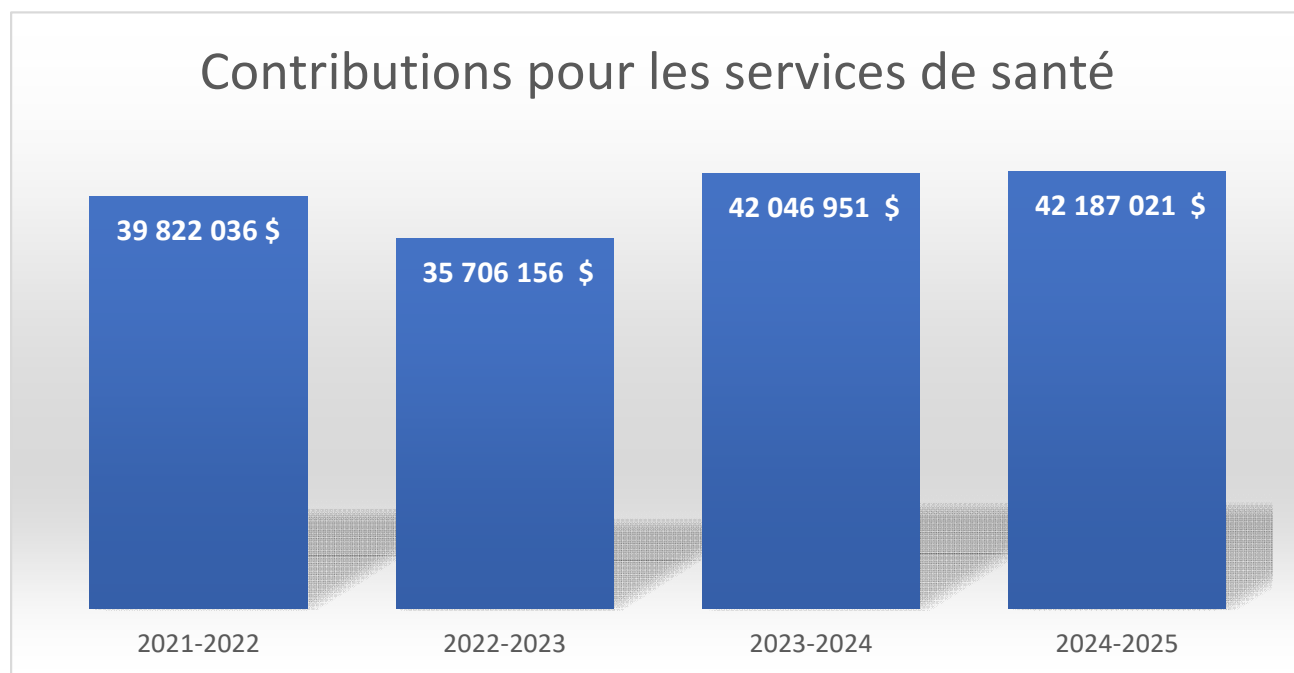
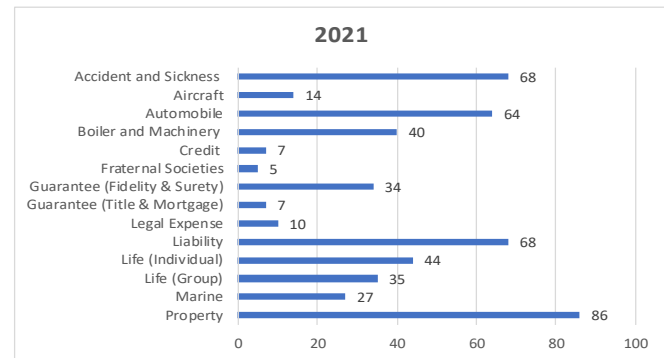
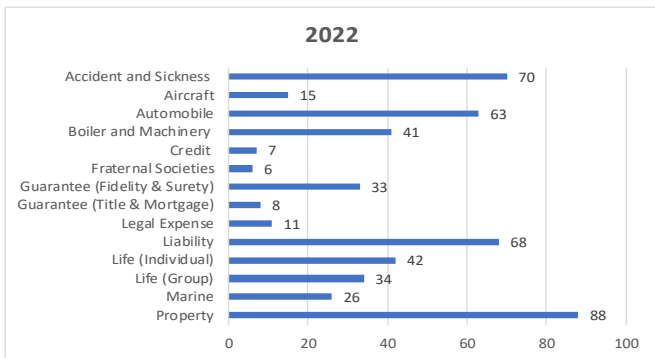
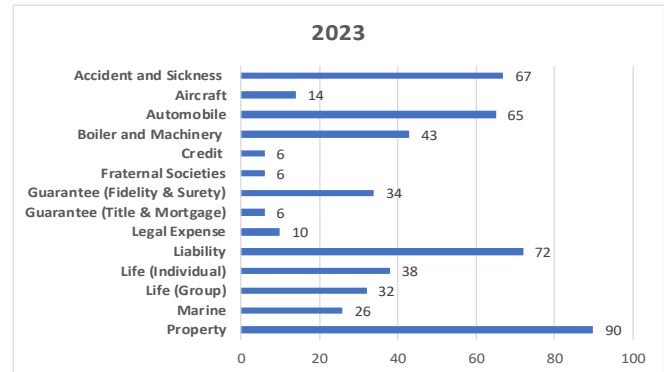
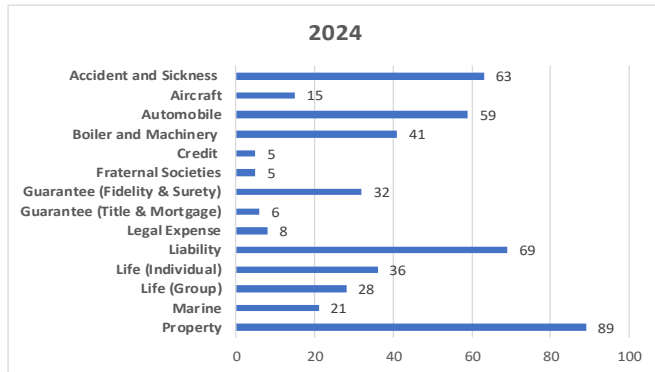

As of July 1<sup>st</sup>, 2013 the Insurance Branch became part of the new Financial and Consumer Services Commission. The legislation surrounding this change affected the deposit requirements of Insurers within New Brunswick. Sections 37 to 70 of the Insurance Act which related to the requirement of insurers carrying on business of Insurance to have a deposit of approved securities with the Minister of Finance have been repealed.

Under the amended legislation sections 70.1 authorizes the Superintendent of Insurance to request that an insurer deposit securities of specified amounts and time frame of payment. At this time, no deposits have been requested. All deposits that were held for Insurers were returned on July 19, 2013. There are currently no deposits held by the Province of New Brunswick.

La Direction des assurances fait partie de la nouvelle Commission des services financiers et des services aux consommateurs depuis le 1er juillet 2013. Cette modification législative a eu une incidence sur les exigences relatives aux dépôts auxquelles doivent se conformer les assureurs qui exercent leurs activités au Nouveau-Brunswick. Les dispositions des articles 37 à 70 de la Loi sur les assurances qui concernaient l'obligation pour tout assureur exerçant ses activités dans la province d'avoir un dépôt de valeurs mobilières autorisées auprès du ministre des Finances ont été abrogées.

Selon l'article 70.1 de la loi modifiée, le surintendant peut exiger, à n'importe quel moment, qu'un assureur dépose les valeurs mobilières qu'il juge acceptables, selon le montant qu'il estime nécessaire et aux conditions qu'il estime appropriées. À ce jour, aucun dépôt n'a été réclamé. Tous les dépôts conservés au nom des assureurs leur ont été restitués le 19 juillet 2013. Il n'existe actuellement aucun dépôt détenu par la Province du Nouveau-Brunswick.
